- Installing VeriSign SSL Security Certificate on the computer that will communicate with USPS (if needed for Mail.dat Batch upload)
- Companies without Window Book's DAT-MAIL™ mailing software will get trial code of DAT-MAIL™
- Companies already with DAT-MAIL™ will get additional training on transitioning to eDocs
